Re: Combined Scrutinizer's Report on results of Remote E-Voting and voting through Polling/Ballot Paper Conducted on the resolutions placed at the Extra-Ordinary General Meeting of the Company on 30th March, 2019 at 11:00 AM

- I, Ms. Priti Lakhotia, Practicing Company Secretary, (CP No: 12790) have been appointed by the Board of Directors of Merino Industries Limited ("the company") as the Scrutinizer for the purpose of remote e-voting and voting through Polling/Ballot Paper received from the equity shareholders carried out as per the provisions of Section 108 of the Companies Act, 2013, read with Rule 20 of the Companies (Management & Administration) Rules, 2014, as amended, to ascertain the requisite majority in respect of the below mentioned resolutions at the Extra-Ordinary General Meeting(EGM) of the Company held on 30th March, 2019.
- 2. The Management of the company is responsible to ensure compliance with the requirements of the Companies Act, 2013 and Rules thereto relating to voting through electronic means on the resolutions contained in the Notice dated 04<sup>th</sup> March, 2019 of the EGM of the Members of the Company. My responsibility as Scrutinizer's for remote e-voting and voting through Polling/Ballot Paper is restricted to make a Scrutinizer's report of the votes cast "In favor" or "Against" on the resolutions stated below, based on the report generated from remote e-voting system provided by the CDSL, the authorized agency engaged by the Company to provide remote e-voting facility and the Polling/Ballot Paper received from the equity shareholders at the venue of the EGM.
- 3. In terms of the aforesaid Notice and as per the provisions of section 108 of the Companies Act, 2013 (the 2013 Act) read with Rule 20 of the Companies (Management & Administration) Rules, 2014, the remote e-voting was kept open for 3 days and the e-voting period commenced on 27<sup>th</sup> March, 2019 at 9.00 A.M. and ends on 29<sup>th</sup> March, 2019 at 5.00 P.M. and members were requested to cast their votes electronically conveying their assent or dissent in respect of the resolution on the e-voting platform provided by the RTA.
- 4. The members of the company as on "cut-off" date i.e. 23<sup>rd</sup> March, 2019 were entitled to vote on the resolutions proposed in the notice calling EGM of the Company.
- 5. At the end of the remote e-voting period on 29<sup>th</sup> March, 2019 at 5.00 P.M, the voting portal of the service provider was blocked forthwith.



- 6. At the EGM of the Company held on 30th March, 2019, the Chairman at the end of the discussion on the resolution(s) announced the voting through Poll/Ballot Paper to facilitate the members present at the meeting who could not participate in the remote e-voting to record their votes.
- 7. Immediately after the conclusion of the e-voting at the venue of the EGM on the 30th March, 2019, the votes cast at the venue were counted, thereafter the votes cast through remote e-voting were unblocked in the presence of Mr. Anirudh Das and Mrs Priti Agarwal who acted as witnesses as prescribed under Rule 20 (4) (xii) of the Companies (Management and Administration) Amendment Rules, 2015.
